PRESIDENT'S MESSAGE

As you probably know, The Illinois Supreme Court ruled on Monday, March 3, 2014, that all four lawsuits challenging last year's pension "reform" law will be consolidated and heard in Sangamon County. So now we wait...and hope that constitutionality will prevail.

WLSU's initiative for the next several months will involve getting the Fair Tax Amendment on the November ballot. You may know that the Republicans in the legislature have unanimously signed a resolution against the Fair Tax Amendment, and some are sending out misleading information with regard to it. Jim Durkin recently sent out an email petition claiming that such a tax would lead to higher income tax rates for everyone making over \$18,000 a year and costing Illinois jobs. The gradations for income levels under a Fair Tax would have to be determined by the legislature. It would be the job of the legislature to morally and ethically set those levels. Ralph Martire of the Center for Tax and Budget Accountability suggests one model under which 94% of all taxpayers—those with under \$150,000 in annual base income--would receive a tax cut. Such a model would provide for \$2.4 billion annually in new revenue and stimulate the growth of at least 36,000 jobs in the state's private sector.

Illinois is only one of 7 states to have a regressive flat tax. A Fair Tax is more equitable than a flat tax because it is the only tax which increases or decreases with ability to pay. A flat tax places the greatest burden on low and middle-income families. Illinois has the 3rd highest tax burden on low and middle income.

It is not true that the highest tax rate that you reach becomes the tax rate for all of your income. A Fair Tax rate would not be levied against one's total earnings but rather only on new money beyond the threshold determined by the legislature. Example: If the state determines that \$150,000 is the threshold amount to start taxing at a higher rate and you earned \$151,000, you will pay the higher rate only on that top \$1000. John Dillon's February 12 blog has a good explanation.

Our neighbor states with a Fair Tax have achieved the following: Iowa--\$6.3B in additional revenue (0.36%-8.98%); Missouri--\$1.8B (1.5%-6%); Wisconsin--\$3.6B (4.6%-7.75%); Kentucky—\$1.6B (2%-6%). Minnesota has one of the highest tax rates of 9.85% on income earners of \$250,000 and has seen job growth between 2% and 2.9% since 2009 – see the article "Right v. Left in the Midwest" in the November 23, 2013 *New York Times*.

The other argument you hear from legislators is that Illinois is a poor, high-spending state. They cite that the temporary tax hike did nothing to bring down our debt because we spend too much. The fact is that Illinois is the 5th wealthiest state in the Union according to GSP (Gross State Product) and, according to the Federal Bureau of Economic Analysis, despite ranking fifth in population and 13th in *per capita* state Gross Domestic

Product, Illinois is ranked 43rd in state spending as a percentage of GDP in FY 2008. Illinois has been cutting General Fund spending in real terms over time. After adjusting for inflation, Illinois General Fund spending was 5% lower in FY2011 than it was 16 years earlier.

Illinois does not overspend on services. We are trying to pay for the same or better services for more Illinois citizens at higher costs without raising new revenue.

If more money is collected in taxes under a Fair Tax, the legislature should pay first the \$8 million it owes to vendors.

The next step is to get Michael Madigan and John Cullerton to call the joint resolution to the floor. We have to be sure there are enough yes votes on it before or on May 1. The Resolution has to be voted on 180 days before it appears on the November ballot. WLSU is counting on your help to spread the word about the necessity for a Fair Tax. It requires a 3/5 majority vote in the House and Senate to pass. Talk to your legislators about the need for a Fair Tax in Illinois.

Membership Report

Well, now we wait. There is no IRTA Call to Action asking members to contact or visit legislators to lobby them to oppose any pension bill that reduces our pensions. The pension theft bill, Senate Bill 1, passed in early December by the slimmest of votes. Unless overturned, it will greatly diminish our annual cost-of-living adjustment (COLA). The COLA, which begins at age 61, is currently set at 3% compounded annually. Under the new formula you can expect an annual COLA increase of approximately \$I,000 depending on years of teaching service. However, should we be encouraged in our wait by the favorable pension ruling for state retirees in Arizona this past February? Yes, on one hand, we should. Arizona, Illinois, and New York are the only three states with constitutionally mandated protections for state pensions. Also, in Illinois, there are several antedated court cases that have upheld the pension clause in the Illinois Constitution.

Should we be overly encouraged by the Arizona ruling? No, we should not. The Arizona Supreme Court ruled that the state effort to curtail benefit increases to retired judges was unconstitutional. The ruling did not directly cover other retirees. As you probably know, House Majority Leader Michael Madigan made sure judges were the only Illinois pension system exempt from Senate Bill 1. He did not feel judges could be impartial ruling on diminishing their own pensions. He wanted to rid them of the burden of a conflict of interest. He also confidently stated on TV "at least four members of the Illinois Supreme Court will approve (his) bill." There are seven justices on the court. Three justices are elected from Cook County and one from each of the other four districts. It seems like a conflict of interest that judges should be exempt from the law in order to foster a favorable ruling for the state. Actually, the conflict of interest subterfuge seems more like a bribe. Let's hope it backfires.

If it does not backfire, and we get an unfavorable ruling, look for the suit to move to the U.S. Supreme Court because contract rights are protected under the U.S. Constitution. Included in the U.S. Constitution in Article 1-Limitation of Powers of States, Section 10, it says, "No state shall...pass any...ex post facto law or Law

impairing Obligations of contracts..." The Illinois Constitution states in Article XIII-Pension and Retirement Rights, Section 5, that membership in any pension system shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired.

This may take a long time to resolve. The IRTA is suing on your behalf. A long legal battle takes a lot of money. As members we should support this effort by contributing to the IRTA Legal Defense Fund. The money is in a dedicated fund and cannot be used for any other purpose. As of February 20th, the current total is \$252,000 with \$63,700 having been expended. Send what you can afford to IRTA, 620 N. Walnut Street, Springfield, IL 62702. Make the check payable to IRTA, and write "Legal Defense Fund" on the check memo line.

Besides sending a check, why not help by increasing membership in the IRTA and WLSU. Be proactive by talking to retired colleagues who are not IRTA members or who may be members of IFT or IEA Retired. Many of us currently belong to the IRTA and one of the other retired teacher organizations. The cost of belonging to two organizations is hardly prohibitive when you compare it to your monthly cable or smart phone bill.

The WLSU membership committee is in need of names and addresses of retired teachers. Our WLSU unit encompasses 39 school districts, and last June, 149 educators retired. The school districts have been very cooperative about telling us who is retiring, but they rarely give us a home address. Once the teacher retires, we have no way to contact him again. Schools do not forward mail to retired teachers. We need WLSU members to give us any names and addresses of retirees from your former school district. Email us at jtszot@comcast.net or darcarmac@aol.com. If you are concerned about violating someone's privacy, be aware that information such as addresses, phone numbers, relatives' names, maps, and often ages are available on the online white pages. We do not share our lists of retirees with any organizations other than the IRTA.

We would also like another member for our membership committee. If interested, email or call one of us. The only requirements are a willingness to volunteer and ownership of a working computer. It's a great way to learn about the workings of the IRTA and WLSU.
