Membership Report

We who are members of IRTA realize the value of our membership. IRTA leads the fight for retiree pension rights through being aware of any threat to our well being that may arise in Springfield and lobbying to allay that threat. When we are threatened, IRTA springs into action as it did against Senate Bill 1, the pension theft bill in 2013, and more recently when the Governor's budget proposed cutting off all monies to TRIP/TRAIL. This has been resolved in our favor. Beside pension protection, the IRTA endorses and provides member benefits that range from dental insurance to rental car discounts. It also has a compassionate side helping retired educators in acute financial distress, providing cash grants to active teachers for classroom projects, and offering scholarships to future teachers.

Your membership in our local, West Lake Shore Unit, also benefits you, but in other ways.

- WLSU keeps the local member INFORMED via email about pension and health insurance issues above and beyond the information from the IRTA.
- WLSU provides DIRECTION, LEADERSHIP and STRUCTURE in respect to dealing with pension and health benefit issues.
- WLSU maintains an ORGANIZED SYSTEM TO INFORM THE MEMBERS in a short time frame of any "crisis" situation related to the pension or health insurance. (Phone tree and net alerts)
- WLSU publishes a QUARTERLY NEWSLETTER, which includes legislative, pension, and insurance information in addition to health and safety news.

- WLSU conducts FOUR MEMEBRSHIP MEETINGS during the year at which the local's issues are discussed along with reports of what is happening in Springfield.
- WLSU conducts a variety of MEMBERSHIP FUNCTIONS, which encourage the members to maintain social contacts with other retired teachers.
- WLSU and other locals provide the BACKBONE OF IRTA and do much of the recruiting, record keeping, and organizing that allows IRTA to function most efficiently.
- WLSU PROVIDES HELP and information to all members who have any questions regarding retirement benefits or other issues.
- WLSU members annually CONTRIBUTE THOUSANDS OF DOLLARS in school supplies to a selected school in the WLSU area.
- The WLSU Executive Board is comprised of unpaid VOLUNTEERS who contribute many hours of time to safeguard the pension and health benefits of members.
- Membership in WLSU is FREE the first full year with minimal dues thereafter.

Sitting on the sidelines and not being involved in protecting what we all have worked for these many years should be unthinkable. However, we all know colleagues from our teaching days that did exactly this. With the recent Janus U.S. Supreme Court ruling disallowing fair share, more active teachers will decide to sit on the sidelines to save a few dollars and let others carry the financial load but still reap the benefits of membership. This carries over to retirees also. The number of non-participating retirees is unfortunately quite large. Two-thirds of all TRS annuitants do little to protect their economic lifeline. We who are in the remaining third should feel satisfaction that by our membership we are resisting those who would like nothing better than to 'diminish and impair' what we have earned in our pensions. We must resist this both for ourselves and for those who will follow. As Margaret Mead said, "Never doubt that a small group of thoughtful committed citizens can change the world. Indeed it is the only thing that ever has."

This issue of *Direct Line* begins our renewal process for 2019. All current members who pay WLSU dues on an annual basis will receive a <u>renewal letter the first week of October</u>. This letter will contain a form explaining exactly what is owed and how to proceed. The mailing label on this newsletter will show your current dues status. An '18 behind IRTA and/or WLSU indicates that dues are owed for next year. Those owing IRTA dues will received a separate letter from IRTA in late October. Assisting Retired Educators

Financial aid to retired teachers: The Foundation provides monthly financial assistance to retired educators who are living in times of acute financial stress. In addition, emergency assistance is also given on an as-needed basis. If you or anyone you know is having difficulties meeting financial obligations, please submit a financial assistance form to IRTA, 828 S. Second St., 4th Floor, Springfield, IL 62704, for consideration. One need not be a member of IRTA to qualify. You can download the financial assistance form from www.irtaonline.org. Assisting Current Educators

Being an educator, do you often think of the phrase—Extra Funds Needed--when it comes to planning special projects for your students? Due to recent state budget cuts, you may be finding that additional revenue sources are no longer available for such unique activities. Through its Excellence in Education Grants for Teachers, IRTA is making \$36,500 in grant money available statewide in Illinois. This special grant will provide additional funds to public school educators (Pre-K through 12)so that their students will have the means to participate in special projects. The application can be downloaded from the IRTA website www.irtaonline.org.

Assisting Future Educators

The IRTA Scholarship will be awareded to one full-time student each academic year for each Foundation area. The recipient shall receive a grant of \$750 each for fall and spring semester, totaling \$1,500 for the year, to be used for educational expenses. The student must be accepted into a Teacher Certification Program in order to receive the scholarship and must be a resident of Illinois or have graduated from an Illinois high school. He/she may attend school in any state as long as the school attended maintains an accredited teacher training program and he/she maintains at least a 3.0 GPA on a 4.0 scale.

The Comptroller and TRIP/TRAIL Health Insurance

An email from Jim Bachman May 15, 2018 Dear IRTA Members,

At a recent meeting of the TRIP Advisory Committee we were notified by the Department of Central Management Services (CMS), that the Comptroller had not made the State's payment to the Teachers Health Insurance Security fund since January 2017. The State's payment is approximately \$10 million a month. Therefore, the State currently owes the fund approximately \$170 million.

The fund is where all TRIP money is deposited. The fund has the following contributors: TRIP participants' premiums, Active teachers (percentage of payroll), School districts (percentage of payroll), State of Illinois (matches the active teachers' portion) and the federal government. Due to the lack of the State's payment insurance companies are not being paid on a timely basis as in the past. Therefore, if the insurance companies are not getting paid in a timely manner the doctors and hospitals are not receiving their payments in a timely manner either. CMS has told us some payments have been delayed as much as 200 days.

The IRTA's contract lobbyist and I met with the Comptroller's office recently to discuss the lack of payments to the fund. As we assumed, the Comptroller does not have enough revenue to make all required payments on a monthly basis. Therefore, she has decided to make the most necessary payments first and if money is available she will make payments to other needs.

In addition, I asked our law firm of Tabet, DiVito, and Rothstien to provide us an opinion on whether IRTA had standing to sue the Comptroller to compel her to make payments to the Teachers Health Insurance Security fund. In short, our law firm replied that the IRTA can bring a mandamus action to compel the Comptroller to pay TRIP payments.

A lawsuit would be a last resort. What we are asking you as TRIP participants is if you begin to experience your doctors or hospitals asking for payment up front for any procedure in lieu of them waiting for payment from the insurance company to notify the IRTA. At that time the IRTA Board of Directors will determine our course of action. Sincerely, James Bachman, IRTA Executive Director

Because of your donations, a 3rd grade class was able to use the glue you donated to make reports for Black History Month, a 4th grade class was able to use the permanent markers you donated for their Wonder project, an art class was able to use the pencils you donated for their drawings, and many classrooms were able to use the tissue boxes during the heavy flu season. Because of your donations, we had prizes to incentivize our students for good behavior each week. Because of the backpacks you donated, children coming into our school after a sudden move from as close as the Southside of Chicago and as far as Nigeria, had somewhere to hold their supplies and give them a sense of normalcy. Our middle school students had fresh notebooks and folders at the middle of the year when theirs were falling apart. The list goes on and on.
