President's Message

Someone please help my muddled brain understand the governor's reasoning.

He won't agree to a budget unless his political agenda is met: business-friendly reforms that will "recharge" the state's economy such as killing unions, (By the way, the distinction some legislators and the Illinois Policy Institute tries to make between unions and taxpayers is specious. Union workers are taxpayers.), creating right to work zones, preventing unions from contributing to political campaigns, lowering workman's comp payouts, ignoring the prevailing wage, lowering the minimum wage, and allowing for municipal bankruptcy, etc. Instead of presenting bills that reflect these ideas to the House, the governor is stumping across the state in a divide and conquer move to influence local governing bodies to vote for them. Many of these bodies are not even clear about the repercussions of those ideas for which they are voting. Keep an eye on your local town or village meetings, and voice your concern should the Turnaround (Turnback) agenda come up for discussion.

He says all of these measures and more will make the state more competitive and attract more business and jobs. However, ³/₄ of the businesses we have in the state already pay no taxes. We are told that the business tax rate is high; however, with loopholes and EDGE credits, many businesses don't pay any taxes. In addition, several businesses get the EDGE, plus are allowed to keep the state taxes they collect from their employees to add to their bottom line, money which should go to pay for services of the state. In addition, retailers are allowed to keep 1.75% of the sales tax they collect on each purchase. Check your register receipts for that 1.75%.

How is this helping the state finances?

So here is the plan as I understand it: Attract more businesses who don't have to pay taxes, can pay less than the prevailing wage, eliminate vacation and sick days for their employees, don't have to pay a fair compensation if their employees get hurt on the job, get to keep the state taxes they collect from their employees, don't have to insure job security, fund private and charter schools to the detriment of public education which serves all students, and enter fund raisers through the back door (as he did in Oak Forest) to avoid being confronted by the people whom his anti-middle class agenda will affect negatively.

Yes! I can see that *might* be a great plan to attract businesses who will provide low paying jobs while collecting big profits, paying little if any tax, and having no accountability. But wait—where does that leave the average middle-class, tax paying, low-wage individual who is trying to make ends meet while paying more for utilities, medical expenses, food, and the services the state is supposed to provide for the vulnerable? What am I missing?

Meanwhile, Minnesota's governor, Mark Dayton, raised the minimum wage, raised taxes on the wealthy by 2%, and guaranteed equal pay for women, among other measures. Despite Republican warnings that businesses would flee the state and take jobs with them, Minnesota's economy is booming. Every time I drive around the Twin Cities, I see new business construction. The state added 172,000 jobs during Dayton's first four years in office. Its unemployment rate is among the lowest in the country, and the Twin Cities have the lowest unemployment rate of any major metropolitan area. Governor Rauner needs a better role model than Wisconsin's Governor Walker whose tenure has brought about a serious decline in the middle class and draconian measures that have demoralized teachers and public workers. He should look a little farther northwest to Minnesota. **Marge Sucansky**

Membership Report

The IRTA spent just under \$600,000 defending your COLA and health benefits before the Illinois Supreme Court. Almost before the ink was dry on the decision, the opposition was planning how to get around it. The IRTA has been in the forefront protecting retired teachers' benefits and has pledged to sue again if your pension or health benefits are threatened.

Last year the organization initiated a new membership drive, "One-Bring-One" which aims to increase membership in IRTA up to 40,000. IRTA is proud to claim about 35,628 of an estimated 100,000 Illinois retired teachers. But, we need more retirees involved in IRTA if we are to succeed in overcoming the challenges ahead. One-Bring-One is a membership activity. Personal contact is the most effective tool in recruiting new members. That is why we need your help. We are asking you to bring one new member to join IRTA before year's end. How?

- 1. Contact **active teachers** from your former school district. If they are in the pipeline to retire, they can join IRTA free for up to four years. They must commit to dues deduct on the application.
- 2. Contact a **retiree** who is a **nonmember** and invite him/her to join, and/or attend a WLSU meeting or luncheon. Retirees are eligible for free, current-year membership by choosing dues deduction on the application.
- 3. If you cannot recruit a new retiree or bring in a retired nonmember to meet your One-Bring-One obligation, please consider signing up your spouse or significant other as an **Associate Member** of IRTA. Many of our WLSU Board members have done this. Associate Membership is available to noncertified individuals and is only \$25.00 per year or Life Membership for \$125.00. Associate Members are also eligible for all benefits offered through AMBA, our Member Benefits provider. If a surviving spouse is already an Associate Life member, he/she may continue as an Active Life member without further dues payment.

Please consider one or more of these options to help us create a strong voice for retired educators. Our future depends on your help. An IRTA-WLSU application is on Page 4 of this newsletter.

The August-September issue of *Direct Line* begins our renewal process for 2016. All current members who pay IRTA and/or WLSU dues on an annual basis will receive a <u>renewal letter the first week of October</u>. This letter will contain a form telling exactly what is owed and how to proceed. Check the address label on this issue of the newsletter; it will tell your current dues status. A '15 behind IRTA and/or WLSU tells dues are owed for next year. Teaching Behind the Cheddar Curtain--Will our State Become the Next

Wisconsin? Illinois Governor Bruce Rauner has been described as Governor Scott Walker on steroids by his backers on the right. Forces, who would like to control your pension monies, fully support the agenda of the two governors. Will Governor Rauner achieve what Governor Walker has achieved in Wisconsin? Let's hope not. Read the excerpt of an email below from a cousin of one of our WLSU board members, received this past May. You decide if you want our state to become a clone of Wisconsin.

The consequences of Act 10 five years ago: "We have no collective bargaining, and have received about 1.3% raise each year with no 'steps' to reflect experience. Six unpaid days were added to our school year 4 years ago, and there's nothing we can do about it.

We tried to fight it by protesting at the capitol building and in the courts. The WI Supreme Court judge was appointed by Walker, so it was determined that there is nothing in the WI Constitution that states you can't discriminate against certain groups of public employees. (The state police, sheriffs and firefighters are not bound by Act 10; they are the 3 groups who supported Walker's first campaign.) He is now talking about going after our pension, turning all of it into 401k plans after removing millions of dollars in interest. He claims that money belongs to the taxpayers, not the teachers.

Walker has removed the Secretary of State, head of Dept. of Natural Resources, and head of the Treasury, and he is now in charge of all decisions made in all of those departments. It's a dictatorship here, and... it's particularly disturbing that this precedent is even being considered a model for other states.

We were cut to \$75 per student from the state when Walker first took office, and with his reelection, he has cut public schools to \$0 per student, while giving \$1500 per student to private charter and voucher schools. I have all the requirements to be certified as a reading specialist, but they will only give me the license if I **don't** work for a public school. Whenever a teacher leaves, he/she is not replaced. I am averaging 70 hour work weeks this year, and [my husband] and I had a long discussion about whether I should sign my contract for another year. However, it's 5 more years until I can retire, and though our health insurance costs have risen, it's still one of the better plans out there.

We have a 190 day contract (including 6 unpaid days), and work until the end of the 2nd wk. of June every year. Spec. Ed. teachers start August 17th this year...again with no pay until August 24th....

...It's difficult to keep working so hard and be treated so poorly and with disrespect. The latest projections in WI are that only 5% of graduating high school seniors are choosing teaching as a career. I am hoping the Democratic legislature in Illinois will block all Republican plans to emulate WI. ...I am very much looking forward to summer break, but we have been assigned a book to read over the summer as a book study. That would be funny if it wasn't true! ...Take good care, Mary"

Legislative Update July 2015

WRITE THE GOVERNOR!

Our best advice from state legislator visits in the last two months may be surprising. When we ask, "What is the most effective thing we could do as retired teachers to help you protect our pensions," the unified answer has been, "It would help if you all would speak directly to the Governor."

Our first response to the suggestion was not positive—"Well what good would that do? He doesn't listen, seems unaware of our needs, openly argues his anti-labor, anti-union, anti-collective bargaining stance and he is ignoring the recent Illinois Supreme Court decision overturning Senate Bill 1— so why would letters from individual retired teachers (or police or firefighters) make any difference?

Because----The Governor needs to hear your voice; he needs to hear our voices-- one and many. If we are silent, we have failed in our advocacy. In this case writing your congressperson isn't the right choice—contacting the Governor is. Hearing from us individually, not through our union reps or our sympathetic congressperson lends a new level of pushback to the debate over the unbalanced budget and the Governor's 500+ page plan to again attack our pensions and ask us to take a diminished benefit.

Your letter does not have to be long or full of research. It does have to be heartfelt in your defense of your contract with the State of Illinois to provide you with the pension you worked for and contributed toward all those working years. I encourage you to send Bruce Rauner a letter at:

Foundation Announces 2014-2015 Scholarship Winners

Each year the Foundation awards six \$1500 scholarships, one in each of the six IRTA Areas. This year, there was a total of 27 applications statewide for the scholarship. Five of those applicants were from Area 3.

The Area 3 recipient is Ashley Sheets who attends Eastern Illinois University and is pursuing a degree in Elementary Education with plans to obtain middle school endorsements in language arts and social sciences. Ashley, who is from Bismarck, IL, is a member of the Mark Twain Mentoring Program and also does volunteer tutoring at the Newman Center. Ashley received an Associates of Science and Arts degree from Danville Area Community College.

In addition to the scholarships, the IRTA Foundation is currently assisting ten retired teachers with monthly checks that range from \$300 to \$650. The total assistance for 2014 was \$48,400. This amount also includes several annuitants who received one-time payments because of a special need. The application for assistance can easily be downloaded from the IRTA website.
