The 2023 Convention will be a great chance to meet in person IRTA members from around the state You will experience speeches, floor debates, legislative highlights, raffles, silent auctions, a lovely banquet, and social interactions. Spouses and significant others are welcome, but you must pay their registration fee and meals. He is a former professor at the University of Notre Dame and is the author of several books, including *Plato's Lemonade Stand* and *If Aristotle Ran General Motors*.



How to Replace Lost Documents

In the previous *Direct Line* I gave you some suggestions for replacing important documents which you may have lost. Here are more suggestions for replacing documents. (All courtesy of the *AARP Bulletin*, December 2022.)

Birth Certificate: Contact the vital records office of the state where you were born. If you were born overseas to American parents and they registered your birth with the American embassy, you can get a birth record from the State Department. If you were born on a military base abroad, you will need to contact the hospital where you were born.

Marriage Certificate: Contact your state's vital records office. They will tell you how to proceed and what documents you will need to provide. If you were married abroad, contact the embassy or consulate where you were married, and they will assist you in obtaining a certified copy of your marriage document. If you were married abroad before 1989, and the wedding was witnessed by a consular officer, the State Department should also have the documents on file.

Social Security Card: You may not need a replacement card as long as you have your number safely stored. If you are starting a new job, or live in Pennsylvania, you'll need your card to obtain a Real ID. To get a new Social Security Card, you'll need a birth certificate, driver's license or state issued ID card OR simply your passport. You may get and print an application on the Social Security website (ssa.gov). Mail or take your application and document to your Social Security office (locations available on website.)

Will: Laws pertaining to wills and estate planning vary from state to state. In general, if your will was lost or destroyed, but not revoked, it still represents your wishes. Upon death a copy of the will can be submitted to the court. However, there must be clear evidence that it has not been revoked, which means that there must be evidence it was lost or destroyed or testimony from an impartial third party stating that you didn't plan to change it.

P.S. The REAL ID deadline has again been extended. The new deadline is May 7, 2025

MEMBERSHIP Is the Bot Value

If you are new at retirement or are an old hand at it, we all share at least two major concerns. Possibly the more concerning of the two is the state of our health. The second worry is will our money last as long as we do. I'm sure we have other concerns that may

cause sleepless nights, such as worrying over an aging or ill parent or spouse, strained family relationships, the changing environment, growing crime and violence, concerns about grandchildren and their future, etc.

We may enhance our health and live longer, according to experts, by controlling our diet, getting exercise, trying to get enough sleep, staying in touch with our health care provider, staying away from alcohol, drugs and tobacco, and avoiding isolation. Fortunately, as a retired Illinois educator, you have access to subsidized health care.

Will your income meet your needs well into retirement? We all wish to live comfortably in our senior years. Besides supporting those groups such as IRTA, IFT and IEA who offer to protect our pensions, we need to pay attention to our spending. One plan used by some retirees is the 50/30/20 rule. This is a budgeting technique that involves dividing net earnings into three primary categories. Fifty percent is to go to pay for needs (food, housing, transportation, etc.), 30 % is to go for wants (dining out, vacations, gifts, etc.), and 20 % is to be saved or go for debt payments (credit card payments and taxes). According to the advice of those who major in personal finances, it is always wise to spend less than your pension allows and don't neglect building an emergency fund in case you need to pay for a new furnace, roof, unexpected condo assessment or unforeseen medical expense. Fidelity Investments recommends that if you retire at age 60, you should have 8 times your income saved. Fortunately, if you don't have this much saved or invested, your defined benefit pension is your lifeline to your retired future.

One thing you can rely upon is the backing and support of the IRTA/WLSU. The number one priority of the IRTA is the protection of your pension. IRTA also has a stake in protecting your state-sponsored health benefits. For example, recently the IRTA sued the state of Illinois challenging the underfunding of the Teacher Health Insurance Security Fund. The initial response from the state appeared to mean that it believed teachers have a constitutionally protected right to participate in some type of health insurance program, but not to any particular level of benefits. This is to be determined by the state, and this is why the state decided to put less into the security fund than in previous years. The IRTA strongly disagreed with this argument, sued and pledged to continue to advocate for your rights. This important issue has been resolved thanks to the IRTA leadership. There will be more to come on this from Jim Bachman, the IRTA director. This is an example of your dues at work. However, dues only go so far; we can do more to help by being multi-year members, recruiting new members, and volunteering to hold an office or some other board role.

This issue of Direct Line begins our membership renewal season for 2024. Please look at your newsletter label to see if you owe WLSU dues. If there is a "23" behind WLSU, it means dues are owed. WLSU dues are 1 year @ \$12, 3 years @ \$30, 5 years @ \$45, or Life for \$125. You may contact Louise Sterett or Tom Szot with any questions or concerns. See the WLSU Contact Information box in this newsletter. If you wish to be an early bird, and we'd really appreciate it, send your check made out to West Lake Shore Unit to Louise Sterett, 770 57th St., #2, Clarendon Hills, IL 60514. Otherwise, you'll receive a notice of WLSU dues owed sometime after September 1. If you receive no notice, you don't owe any WLSU dues.

Please remember that dues owed to the IRTA are separate. If you owe IRTA dues, you'll be billed by them. By the way, if you are considering becoming a life member of IRTA, now is the time before the dues increase.

Be reminded of the quote by Kurt Vonnegut in Cat's Cradle: "In this world, you get what you pay for."

Protect your pension and health benefits by <u>renewing</u>, <u>recruiting</u>, <u>and resolving to help your local unit</u>. Help by telling a friend or family member to Google IRTA. The website will come up. Go to it and click on <u>Association</u>. Scroll down to '<u>Join Now</u>,' or text the word "JOIN" to 70678. Email the person's name to us to guarantee he/she is placed in our WLSU local. Please remember the old saying about there being strength in numbers. Adopt-a-School Project 2023-2024

The Adopt-a-School project is underway again after two years of being dormant due to the pandemic. It was exciting to once again send out letters to schools located in the footprint of WLSU's borders to elicit a potential partnership. As in the past, letters went to schools that had very high percentages of low income students. This year we will be working with Thurgood Marshall School in Bellwood. This school serves students in grades K-5 and currently has 270 students enrolled. The principal, Jeremy Burnham, and I have had a number of conversations regarding how we can be of assistance to both his staff and students.

They are open to receiving the school supplies listed below. He also mentioned a need for volunteers that might be willing to come into the school to work in small groups with students. We had a lengthy discussion about these needs at our last Board meeting and decided that I would present all the needs and let members decide how they would like to proceed.

The Adopt-a-School project has been well received by our members. It has given them the opportunity to help school communities with a variety of needs. My hope is that this tradition will continue into the 2023-2024 school year. I will be collecting donated items at WLSU functions, or you can drop donated items at my home at 427 N Waiola, La Grange Park. We have a large front porch, so feel free to place items there. Items Being Collected: School supplies such as tissues, paper towels, sanitary wipes. pocket folders, backpacks, pencils. markers, crayons, constructions paper, etc. White polo shirts in sizes 4-16. It is part of their school uniform and many of the families have trouble purchasing them. Keeping a supply of them available at the school would be helpful.



Helping Educators: Past, Present, Future

This year the Area 3 \$2000 scholarship was awarded to Christy Arreci, who is a student at the University of Illinois, Chicago. The first half of the scholarship was presented to Christy at the June luncheon, pictured with Vice President Fran Pettersen, Area 3 Rep, Marjorie Sucansky, and Area 3 Foundation Member at Large, Caryn Graham. Christy and her parents, Vanessa and Rudolfo Arreci, were guests at the June luncheon.

In addition to helping future educators, IRTA also provides aid to retired educators who may have particular needs. In 2022 the

Foundation assisted 11 people who were in need. A total of \$54,810. was distributed to these individuals. Currently the Foundation is helping 10 retirees at a monthly cost of \$4625. Please remember that these monies are there to assist any retired Illinois teacher (one does not have to be an IRTA member to apply).

Another aspect of the Foundation's efforts focus on Grants to active teachers. This year there were 32 applications in Area 3. Caryn Graham and Marge Sucansky recommended the \$4000 allotted amount for Area 3 be divided among 6 of those worthy applicants. Final evaluation will be done in August, and the grants will be awarded in the fall. Watch the next *Direct Line* for information about the recipients.

Please note that the Foundation's monies come entirely from donations, not dues. The primary fundraiser for the Foundation will be in the mail soon, so please be on the lookout. Last year the fundraiser generated \$228,938. Any contribution would be appreciated. **Julie Jeter, Foundation**
