

#### **News from IRTA**

The Legal Defense Fund contributions in FY20 were \$3,171, a decrease of \$2,126. The balance was \$153,412 at the end of FY20. The end of year total membership was 39,171, an increase of 487 members... During FY2020, IRTA added 1,800 new members.

During Fy20 the General Assembly met on a limited basis due to the pandemic. The IRTA supported the full funding of both the pension system and Teachers Retirement Insurance Plan. Both were funded at their certified amounts. Andrew Bodewes, IRTA lobbyist, believes April and May will be busy months legislatively and IRTA should be vigilant

## **Membership Report**

Each Spring the Membership Committee gears up to recruit new retirees from our 39 WLSU school districts. If you know anyone who is retiring this year or who may have retired before school opened in the Fall

due to Covid 19 fears, they are good candidates for membership. Even if the retiree is from a district outside of our West Cook area, we should recruit them. It is super simple to join online at the IRTA website, and the year of retirement is free. You may also forward the name and address of any prospective member to Louise Sterett or Tom Szot.



Do you ever wonder or question why you are a continuing IRTA/WLSU member? Is there some value to you in being a member? Check off the reasons that apply to you:

#### A Powerful Retirement Voice

Your IRTA and WLSU stood alone against Senate Bill 2404 that would have forced current teachers and retirees to choose a compounded 3% COLA or subsidized health care. The IRTA also took the lead against Senate Bill 1 that was declared unconstitutional by the Illinois Supreme Court in May 2015. This would have opened the Pension Protection Clause to changes that would have not been in your best interests.

#### **Strength in Numbers**

The IRTA has just under 40,000 members. Legislators see this as 40,000 reasons for protecting teacher rights and benefits. Retirees do vote.

#### **Consumer Benefits**

The IRTA offers group rate dental and vision insurance as well as multiple discounts on all types of goods, services, and activities. The list of benefits can be easily accessed on the IRTA website, irtaonline.org.

#### **Lobbying and Political Action**

The IRTA employs lobbyists who work to protect your interests in Springfield. The IRTA communicates with you via your email to alert you of relevant events in the state capital. Call-to-Action alerts notify you when to contact legislators about your retiree concerns. Beside these alerts, you receive updates regarding significant events in Springfield such as the Budget Address posting on February 17, 2021.

#### **Opportunity to Share**

As an IRTA member you promote a stronger sense of community through the IRTA Foundation. The Foundation provides grants to current teachers, financial support for teacher retirees in need, and scholarships to Illinois students majoring in education. WLSU also continues to sponsor "Adopt a School," where educational goods are provided to one "adopted" school each year. Unfortunately, the program was put on hold for one year due to the pandemic.

#### **Communications**

As a member you receive the quarterly issue of the IRTA's *Action* newsletter and the WLSU's *Direct Line*. In addition, if you have email, you get the IRTA alerts and WLSU Constant Contact updates.

Undoubtedly for retirees, pension and health insurance protection is key. However, as shown, this is only part of why you continue to be a member. We as your WLSU Board earnestly wish that you as members would go a little further and volunteer a little time by serving as a board member and/or helping us recruit new members. Your retiree organization cannot survive and thrive if only a few of us work for the good of the whole. The IRTA Foundation is pleased to announce the 2020 winners of the Excellence in Education Active Teacher Grants. Of the 247 applications that were received, nineteen were from Area 3. Sixty-five Grants have been awarded for a total of \$36,489. Ten of those grants have been awarded to active teachers in Area 3. Among the Area 3 winners are Alan Holtz, who teaches at Brooks Middle School in Bolingbrook, and Josephine Lewis, who is an educator at Jefferson Elementary

School in Berwyn. Alan plans on using his award money to fund a "Battle of the Book" competition, which will motivate reluctant readers. Josephine will use the grant money to purchase STEM kits for the school library. These kits will enable students to engage in critical thinking and problem solving and also foster creativity and teamwork.

TRS recently sent out a press release calling attention to the status of the fund at the end of 2020. Even though their fiscal year ends at the end of June, TRS still does a deep dive and counts all of their money in every financial instrument, including real estate and private equity, at the end of the calendar year. TRS starts 2021 with \$57.2 billion in the fund. That is the most money that TRS has ever had. They have a positive growth of 7.9% in their investments for the last six months of 2020. **Bob Lyons**

## It's Not a Good Idea to Post Your COVID-19 Vaccination Card!

So, you have received your vaccination and are relieved and anxious to share the news with your family and friends. AARP and the Federal Trade Commission (in recent online articles cited below) advise that it's not a good idea to post a photo of your vaccination on social media. As we hear so often, this too may contribute to identity theft and scams. The card contains valuable information such as your full name and complete date of birth. The FTC article says that your identity information may be compared to a puzzle. Identity thieves gather pieces of information about you, and when they have it all, then you may become a target. Even where you received your vaccination needs to remain private as the

Here's what is advised as safe ways to share your good news:

- 1. Post a picture of your arm with the band aid over your injection site.
- 2.
