But It's A Short Trip,



Spend Those Gift Cards!

In Illinois State Treasurer Michael W. Frerichs E-Newsletter, he strongly urges using those gift cards that you may have received during the holidays as soon as possible. He reminds that although bank cards are typically good for five years, inactivity fees can start being added on in less than 12 months. If you misplace or forget about a bank card, chances are that by the time you try to redeem it, a large portion of the balance may have been eaten up in fees.

Restaurant cards and merchandise cards are only good as long as the restaurant or business stays open. (In Illinois retailers and restaurants are not allowed to charge fees on gift cards.)

Illinois Drivers Licenses and ID cards

Licenses and IDs that have an expiration date between January 1, 2020, and March 31, 2022, have been extended until March 31, 2022.

Check the Secretary of State website http://www.ilsos.gov to see if Drivers License facilities are open or closed because of COVID. They are open at the time of this printing.

Membership Report

This report in the *Direct Line* one year ago began with: "Undoubtedly, this past year was one none of us will miss." Unfortunately, not much has changed, at least for the better. We won't miss 2021 either. We have yet another new COVID variant and hospitals are filling again. There are still many people who are unvaccinated. Many of them are angry that their "rights" are being infringed upon by the ma-



jority. Inflation is still with us, and there is a shortage of certain goods. Readers of this column can easily add to this distress list with personal stories.

But again this year, there are personal positives that you enjoy as a retired educator in Illinois. Your pension is still being deposited in your bank. Your Cost of Living Adjustment (COLA) raised your pension amount by 3% in February. Your COLA becomes effective January 1 following either your first retirement anniversary or your 61st birthday, whichever is later. Unfortunately, the Consumer Price Index (CPI) was 7% for the 12 months ending this past December. This is the largest 12-month increase since 1982. Economists give many varied reasons for the rise. Nevertheless, please remember that your COLA benefit of only 3%, in a year of 7% inflation, is always the largest target of any "Pension Reform" legislation.

Another positive is that your health care insurance premium remains steady with a modest increase for some and a small drop in one PPO plan for others. This is despite the fact that health care costs have been rising faster than inflation for years and will likely continue on this course. Fidelity Investments estimates that an average retired couple age 65 in 2021 may need approximately \$300,000 saved (after tax) to cover health care expenses. This does not include the cost of long-term care that many older retirees will find necessary.

This has also been a tough year for your WLSU unit. Unfortunately, 2021 saw double the deaths of members compared to the year before. We lost 36 members. Our total membership number dropped by 57 after years of modest increases. It has been harder to increase our number of new retiree members. Without new members and returning members who renew their membership, the entire structure that supports the work done by the IRTA protecting your pension is weakened. Without our input as IRTA/WLSU members, legislators are free to do as they please. **It is necessary for us to recruit more members**. We need the help of our current members to sign up friends, relatives, current non-IRTA retirees, and new retirees. Enrolling anyone as a new member is very easy to do online. Go to irtaonline.org. On the website, follow directions under "Association" and "Join Now." Any person owing IRTA dues may also renew online.

Coming into the new year, we find that WLSU has approximately 160 members who have not renewed membership for 2022. By the time you receive this newsletter, and if you owe WLSU dues, you'll have received 2 reminders to mail your dues to our treasurer. **Members who do not renew will not receive another newsletter, and all communications will stop in March.** Please send a check to our Treasurer, Louise Sterett, made out to West Lake Shore Unit. Her address is 770 57th St., #2, Clarendon Hills, IL 60514. Renewing for more than one year is an enormous help. Dues are \$30 for 3 years, \$45 for 5 years and \$125 for Life membership. Check your newsletter label or contact Louise Sterett or Steve Yurek if you are unsure of your dues status. See Contact Box for email or phone information. Please remember that IRTA dues do not pay for membership in WLSU. Our unit must collect its own dues.

In closing, it is up to all of us to protect our financially secure retirement by helping out if you are at all able. The large majority of us will live far into retirement, and to enjoy your "golden years" you'll need to keep your pension funds coming in monthly. How long may you live while retired? For an estimate, go to Social Security Administration or simply google, ssa.gov. Click on the Retirement and Survivors Benefits: Life Expectancy Calculator. According to a quote attributed to Mark Twain, "Do not regret growing older. It is a privilege denied to many." Enjoy it while you are able!

The IRTAPAC is a way to protect our benefits. It provides financial support to legislators who support us and thus prevents impairment of our benefits. Many of you may make a yearly contribution to the PAC; however, if you opt for deduct of \$1 per month, from your pension check, that allows the PAC committee to know exactly what to expect as far as funds are concerned. It is a more reliable measure of what funds can be disbursed for lobbying and pro-

tection of benefits. Look for the form on the website: www.irtaonline.org, and sign up for deduct of PAC donations.



News From IRTAIRTA NEEDS YOU AND YOU NEED IRTA

(January 24, 2022 - Springfield, Ill.) - The Illinois Retired Teachers Association (retired teachers, administrators, coaches, counselors, school nurses, et. al) filed a lawsuit Monday seeking to correct an unconstitutional move by the State of Illinois which dramatically reduced contributions made to the Teacher Health Insurance Security Fund. That move worsens the financial footing of the fund, which is already on the verge of default, and places the health benefits of retired teachers in dire jeopardy.

IRTA, HELPING EDUCATORS—PAST, PRESENT, FUTURE

The IRTA Foundation awarded \$37,215 in grant money to 65 active teachers. The grant money will enable these teachers to enrich classroom instruction with materials otherwise unavailable to them. Nine of these grants were awarded to active teachers in Area 3. Jennifer Giernza, who teaches at Jefferson Elementary School in Berwyn, is a local grant recipient.

Information and the application for the 2022 Illinois Retired Teachers Association Scholarship Program is now available on the IRTA website under Foundation Information. An application can also be obtained by contacting Fran Pettersen at narfp@yahoo.com or 708-302-2129. This \$1500 scholarship is available to students who are juniors or seniors in college and have been accepted into an accredited Teacher Certification Program. The applicant must be a resident of Illinois but may attend a school in any state. Also, the applicant must have and maintain a 3.0 GPA on a 4.0 scale. The deadline for the scholarship application is March 7, 2022.

Currently, the Foundation is assisting eight annuitants for a total of \$3425 a month, and one annuitant is receiving assistance with property taxes. **Fran Pettersen, (interim)**
