# **March 11 Membership Meeting**

#### President's Message

Happy 2015 to you all. I hope your New Year has begun well and will continue to be happy, healthy, and prosperous. This is a big year for IRTA/WLSU. We will be celebrating our 60<sup>th</sup> and 50<sup>th</sup> anniversaries, respectively. The board is planning some projects to commemorate these events—more to follow. This year is, also, a convention year, so mark your calendars for October 26-27 when we will be seeking delegates for the event in Springfield. We are usually allowed about 30 delegates, and welcome members to participate.

You might notice that this year we will be having three member luncheons and one non-luncheon membership meeting, and we are investigating new venues. We were pleasantly surprised at our December luncheon at Ashton Place which was able to accommodate us on short notice after Willowbrook Inn was unable to meet its obligation to us.

With regard to SB1, we are still in a wait and see mode. Judge Belz deemed it unconstitutional, and it moved on to the Illinois Supreme Court. Lisa Madigan, Attorney General, has asked for an expedited hearing of the bill and was granted such. That means that our attorneys will have less time to study the state's arguments, with oral arguments scheduled for the March 2015 term of the court.

In the meantime, the temporary tax has expired, leaving Illinois with a \$2.2 billion deficit in the final six months of the fiscal year's budget unless new revenue is found and agreed upon by both chambers and Governor Rauner. In next year's budget there will be a shortfall of \$4.1 billion as a result of the reduced revenue. Some legislators have sent me surveys, asking where to make cuts. If you get such surveys, please respond to them. Governor Rauner must present his budget by February 18.

As always, continue to keep in touch with your legislators as there were several issues unresolved at the end of the veto session among them the minimum wage increase and the graduated income tax. If you have questions about contact information for your legislators, please don't hesitate to contact me via email or phone. #### **Membership Report**

We are proud members of the IRTA and our local unit, WLSU. Why? It is always satisfying to stand up for a principle that is right. Our TRS pensions are a contract entered into at hiring. Political, corporate, and misguided forces seek to change that contract without our agreement. They fail to understand a basic tenet of contract law. It is that one party can't unilaterally nullify or change the conditions of a contract without the agreement of all other parties to that contract. The IRTA was the first group to file in court against SB 1. This law would limit drastically your COLA. It would hurt active teachers even more. The IRTA also stood alone when the We Are One Coalition negotiated, without our consent, SB 2404. We would have been forced to choose between our COLA or our health care coverage. No matter how the Illinois Supreme Court rules this year on SB 1, the attacks on our pension rights will continue. Please continue to stand with the IRTA and WLSU as they work to protect what is contractually and constitutionally yours. According to our adversary Eden Martin, past president of the Civic Committee of the Commercial Club of Chicago, in regard to pension reform, "[This is] not about the law at all, it's about the politics and arm-wrestling over money." Your help is important in combating thinking like this.

Last October the membership committee began our annual IRTA-WLSU renewal campaign for 2015. Typically, more than one-third of our WLSU members need to renew. Are you one of them? You should have received a renewal reminder. If you are unsure, check the address label on your newsletter. Your dues status is indicated there. For those who fail to renew, this will be your last newsletter, and all other communication from our organization will cease in March, 2015. Renewing your membership will guarantee the continuation of these benefits and services:

To support this initiative WLSU is offering a rebate on local activities when you bring in a new member to any WLSU event.


Finally, take heart. Winter is more than half over, right is on our side and we will prevail, but don't think you can sit this one out. Ponder the words of comedian George Carlin,

#### **Two Scam and Safety Warnings**

During the last several weeks there have been two news items from the suburbs that our members, as well as everyone, need to be reminded of. A number of suburbanites have received calls saying that they owe money to the IRS, and in order to avoid immediate legal action they need to follow instructions to authorize payment over the phone. Of course, this is a scam as the IRS, and all reputable agencies, will not ask for any payment via a phone call. The scammers are hoping that with income tax season approaching just the mention of IRS will upset someone enough that the ends up revealing personal financial information that the scammers can then take advantage of.

Also, there have been a number of wallets snatched from purses left open in shopping carts, especially in grocery stores. The snatch happens so quickly that often the shopper doesn't realize anything has happened until reaching the checkout counter. Always remember to close your purse once you've taken out your list, and never place a purse in the child seat of the shopping cart.

Both of these are common sense warnings, but these scams and thefts have occurred enough and resulted in enough calls to suburban police departments that they subsequently ended up asTV news items. #### **Dear Fellow Retirees,**

There was recently an article in the *Chicago Tribune* Business section that you should read. It concerns the State's EDGE (Economic Development for a Growing Economy) program. It has had and continues to have an impact on our pensions.

In the past I've been writing in general about the State's dire financial situation, and occasionally about the State's EDGE program. In short, EDGE is intended to bring jobs to Illinois or to encourage companies to retain jobs in our state. The State will lower a corporation's taxes if it participates in EDGE. The State had good intentions, but corporations quickly found many ways to abuse the program.

For example, Ford is allowed to retain the state income taxes paid by its employees. That's right, monies that the state desperately needs to maintain roads and to contribute to TRS is diverted to Ford's bottom line. Why would Illinois allow such a gross abuse?

The reason is simple: The state unemployment rate was/is high, and other states were/are offering similar programs. Corporations became very adept at playing the states against one another. Archer Daniels Midland, the gigantic agricultural products corporation, was particularly avid. The point is that the state's ability to contribute to TRS is imperiled by these *give-aways*."

# **Complimentary Over 90 IRTA Membership**

To qualify for free membership, one must meet the following criteria:

- 1. You must already be a State Member. A complimentary state membership will not be given to a state non-member or local only member.
- 2. The member or the unit can request a complimentary state IRTA membership as long as the member is state annual or state dues deduct. The member's name, address, and date of birth must be given with the complimentary request.
