Go to irtaonline.org to easily join or even renew a membership or call 800-728-4782 to speak to a real person. Currently, just under one-third of TRS annuitants are IRTA members. We need a larger number so legislators will view us as a bloc of voters to be taken seriously.

We must defend our defined benefit pension. Corporate forces have not given up on their efforts to strip us of our retirement security. We must vigorously oppose any effort to amend the Illinois Constitution to remove protections against pension change or diminishment. To safeguard our TRS pension, we must oppose any effort to cut benefits of employees or retirees in any public pension system. We must also resist forcing public employees into any risky defined contribution retirement plan. We should stand united with all other public employee groups and their representatives.

Make sure you keep your IRTA/WLSU "insurance" up to date. If you are one of the 107 WLSU members who still owe dues for 2024, please pay now. Members who do not renew will not receive another newsletter, and all communications will stop in March. Please send a check to our Treasurer, Louise Sterett, made out to West Lake Shore Unit. Her address is 770 57th St. #2, Clarendon Hills, IL 60514. Renewing for more than one year is an enormous help. Dues are \$30 for 3 years, \$45 for 5 years and \$125 for Life membership. Please remember that IRTA dues do not pay for membership in WLSU. Our unit must collect its own dues.

Update on Drivers' License Facilities

With complications arising in the appointment system begun at Illinois Drivers' License Facilities on September 1, the Secretary of State's office has instituted a number of changes that went into effect on September 25, and Alexi Giannoulias has made it his goal to make things as easy as possible for elderly drivers.

Currently the mandatory age for the mandatory driving test is 79 because senior drivers are the safest in the state. Persons aged 81-86 will be required to take the vision and driving test every 2 years.

Four walk-in centers for seniors have been established and others are planned.

More appointment slots have been added to all facilities, an increase of nearly 1,300 a day. To make an appointment online go to the site by 7 a.m. as slots fill up fast.

Scholarships



2024 Scholarship News

The 2024 application and current guidelines for the IRTA Foundation Scholarships are available. Applications and current guidelines are posted on the IRTA website, irtaonline.org under Foundation. One need not be a member of IRTA to apply.

One \$2,000 scholarship is available in each of the six IRTA Areas of the state. These scholarships are only available to incoming juniors or seniors in college enrolled in a certified teacher training program. The deadline to postmark or email applications is March 7, 2024. Thanks to a generous private donation by an IRTA member, there is an additional \$3,000 scholarship in Area 4 & Area 6.

Other scholarships available in 2024, are the **Moler-Austin Scholarship** which offers two \$4,500 scholarships to KENDALL COUNTY high school graduates that will be entering their Sophomore, Junior, or Senior year of college with a declared major in Education. The **Helen Kennedy Scholarship** which is a \$2,000 scholarship and is available to graduates of any Illinois High School that will be entering their sophomore, junior, or senior year of college with a declared major in Education. Finally, the **Rose Sandstrom Scholarship** is for \$2,000 and is available to one incoming senior in college attending either Western Illinois University or Monmouth College with a declared major in Physical Education.

Applications for any of the above scholarships must be postmarked or emailed and sent to the IRTA office on or before March 7, 2024, and the recipients will be announced by April 21, 2024. The awards will be given as follows: one half in June for the fall semester with the balance to be awarded in January upon registrar verification of a 3.0 or above GPA on a 4.0 scale.

Excellence in Education Grants

Check the IRTA website in the near future for information regarding Grants to active teachers which provide teachers with up to \$750 for a classroom project not covered by their district funds. The application will be on the website, and the deadline for submission is June 1.
